COMPANY NEWS: STATE & LOCAL:

Good news - Apptio, a software brand that Kambrian has sold to LA METRO and LA County in the past, has added Kambrian to their Software License Program (SLP) contract with the State of CA. LOW-VOLTAGE:

Kambrian was awarded a contract by Dorado Design & Construction to complete an electrical installation for Long Beach Transit. Long Beach Transit owns a fleet of battery-powered electric buses and are expanding the amount of charging stations they have in the city. Kambrian is installing (14) bus charging stations which includes underground electrical conduit and wiring to the charging stations, wall mounted area lighting and wiring for charging activities, conduit and wiring from data cabinets to Wifi locations at each charging station, and 120 voltpower to the wall mounted Wifi units.

Another award Kambrian has

received is a 34-site Pepboy's rollout covering the entirety of Los Angeles and Orange Counties with Crosscom. The scope of work for the first trip included the Meraki switch equipment installation and we surveyed each register location for cat6 capabilities. The second trip included cat6 cable installation to each register (up to 10 cables per site). During the final trip, we installed VOIP phones at each register, swapped in new POS systems, and tested the network with customer IT. Tracked deliverables included signed customer paperwork, cable test results, and pictures of installed cable and equipment.

In other cabling news, Kambrian has had the opportunity to begin offering our cabling services in Jacksonville, Florida. We are very excited to continue growing this side of our company.
